#### **Field Turf Update**

Mr. Lubus reported the Money had earned \$10,000 interest and he suggested the total of \$40,000 be put in the field turf replacement fund.

## **Tennis Courts**

The Commission discussed Flash Track had never been charged usage fee. Mr. Lubus explained it was not a usage fee but a replacement fee. The Commission discussed not allowing walkers on when Flash Track had the facility.

Mr. Brown felt they shouldn't charge the fee for Spring because their sign-up was already done. Mr. Lubus felt the Commission would be willing to waive the fee for Spring if they would pay to put up the sign stating track regulations. Flash Track was willing to pay for the signs.
