# 3. Remarks from Chairman Parks & Recreation

Mr. Lubus reported on the joint Field Committee with the Board of Education. The Committee reviewed the revenues to date and figured they need to put away \$50,000 per year. He stated there was a tremendous short fall.

Mr. Brown reviewed his Field Usage Fee Analysis.

Mr. Merullo joined the meeting at 7:15 p.m.

Mr. Brown reported Youth Lacrosse didn't pay for fall '06. He explained the charge was the same if you use the field 1x a week for one hour or if you use the field 5-7x a week for several hours. He reviewed

The Commission discussed marketing events.

Mr. O'Keeffe expressed concern that P&R had no control over how many kids are registered/ pd. In each club.

Mr. Lubus felt they never had an indication Clubs are not being honest with numbers. He felt P&R needs to maintain a trust relationship.

Mr. Loughran asked if the Committee had discussed just raising the fee to \$30. Mr. Brown did not think it was fair, he felt the fee should line up with how the club is using the field.

Mr. Hodge reported on a situation with 'Groovin. He explained in December sound equipment had been ordered, Mr. Hodge used his AMEX card to order the equipment. In January a member of Groovin used his debit card to pay for the equipment. Two monitor speakers were still not picked up. Mr. Moore gave the check from the New Fairfield Community Assoc. made out to East Coast Music Mall to the vendor and the check was cashed. So in fact they had been paid twice. To date the Goovin member's debit card has not been reimbursed. Mr. Hodge reported with the drive-in movie coming up they had no equipment to use, they were not able to the equipment the gentleman from 'Groovin paid for. Mr. Merullo and Mr. Hodge went to East Coast Music Mall and took a complete sound system with 2 monitors as collateral for the cashed check. The Commission discussed.

Mr. Loughran suggested when they talk to the clubs they ask them to commit to run tournaments and split revenues.

Mr. Hanson suggested before going to the clubs the committee needs to look into marketing the field for \$40,000. The Commission discussed changing the fee structure to \$25/\$40.

Mr. Castagnola will call O&G for a better idea of replacement costs.

Mr. Merullo to call John Leary, Danbury High School field manager and ask questions.

The Commission discussed the movie next Friday.

## **Rec-Trak Training**

Mr. Merullo reported Rek Trak training was set up for July 16-18.

#### After School Program

Mr. Merullo reported he met with Consolidated Principal, Jane Harwood. He reported due to conflicts they cannot have the cafeteria on Tuesdays. He explained they need to be out of the gym by 5:00 p.m. for cleaning. Other changes were:

- 1. change 1/2 days to "early dismissal"
- 2. change PTO emergency system to "Alert Now"

He explained parents cannot call the Consolidated office about the After School program. The Commission discussed they need to make a space for the Director in the P&R office. Mr. Merullo reported any Drugs have to be double locked; the nurse will only be on premises for the first 10 minutes.

Mr. Lubus left the meeting at 9:00 p.m. Vice Chair Mark Lamanna took over.

Mr. Merullo felt the After School program was moving forward with some small changes. He felt any space issues could be worked out with Phil Ross. He also felt we need to advertise the program in the Citizen News.

## 4. Sub-Committee Reports

#### FIELDS

Mr. Merullo reported he has the forms for summer usage. He felt they should look at fall soon. He also stated they would need a new Fields sub-committee chairperson.

#### PROGRAMMING

Ms. Anderson suggested the Commission start thinking about the Turkey Run 11/18/07. Sponsor letters should be composed.

#### WATERFRONT.

Mr. Lamanna asked Mr. Merullo to look at the exposed wire in the tree and make sure the handicapped signs were installed.

Mr. Merullo reported they were heavily staffed for the weekends before and after July 4<sup>th</sup>. Mr. Hodge was asking for more police at the parking lot.

#### 5. Parks & Recreation Director's report

Mr. Merullo reported the waterfront was up and running. All the kids had been hired and passed their drug tests.

Mr. Merullo reported the summer Day Camp was ready to go. He explained 7<sup>th</sup> graders were registered in the program because the numbers were low. The Commission discussed. The Commission expressed concern because they have said no 7<sup>th</sup> graders 3 years in a row.

## 6. New Business

Mr. Merullo reported the Golf Tournament was cancelled. He reported there were dates open in September to reschedule. 9/3, 9/10, and 9/24.

The Commission discussed the new Town Hall Hours effective July 1<sup>st</sup>. They felt maybe a drop box for sign ups or a special night for registration may work.
