# Special Meeting Saturday July 21, 2007

### 1. CALL TO ORDER

Meeting called to order at 8:05 a.m. by Chairman Ray Lubus

## 2. Public Comment

Mr. Loughran expressed concern about the Board of Education not putting any money away to replace the turf fields.

## 3. Remarks from Parks & Recreation Chairman

Mr. Lubus reported he gave a report to the Board of Selectmen at the end of June listing the Commissions projects and progress. He felt they were well received.

Mr. Lubus welcomed Ms. Fiamengo and Mr. Burfeind to the Commission.

## 4. Remarks from Parks & Recreation Director

Mr. Merullo reported the office was busy, Day camp was going well. He explained Bids are going out for paving Komlo parking lot.

## 5. Review of Sub Committee Descriptions

#### Waterfront– Mark Lamanna, Chairman

Mr. Lubus read the description of responsibilities for the Waterfront Sub-Committee.

Mr. Lubus introduced Jim Mitchell, Sr. Marina Attendant.

Mr. Mitchell expressed concern there has been no waterfront sub-committee meeting lately. He reviewed his concerns.

- 1. Parking could use new stickers.
- 2. Gate motor leaking oil.

Mr. Merullo explained he had extra staff to handle the added parking. He was informed by the Town Attorney that we do not have to let Non-residents Park if they are not using our facility. He also stated the gate had been serviced Thursday.

3. Drinking – Excessive drinking by young boaters.

Mr. Mitchell expressed concern about excessive drinking by young boaters. He suggested the Commission send a letter to marina attendants. The Commission discussed. Mr. Lubus felt the Commission's jurisdiction was limited if they were not drinking in marina. The Commission felt a marina radio should be purchased so the attendant can call Candlewood Lake Authority or the DEP directly.

4. Boat Size

Mr. Mitchell expressed concern over bigger & wider boats. He asked the Commission to authorize Mr. Merullo to contact the marina tenants in slip 58 & 74 to turn their boat around and park face in.

5. Stickers.

Mr. Mitchell reported still 13 people with no stickers on their boats. The Commission discussed. Mr. Lubus suggested Mr. Merullo send a letter stating a deadline date for sticker if missed they will be fined and be removed from the marina next year.

- 1. not sell parking spaces to non-residents unless they are using our facility
- send to current marina tenants without stickers a letter stating if they do not comply by August first there will be a fine of \$50 and if they still do not comply their contract may not be renewed next year.
- 3. Send a letter to tenants in slip 58 & 74 to turn their boats around and park face in.
- 4. Authorize purchase of marine radio providing CLA will accept calls not to exceed \$250.
