1. CALL TO ORDER

Meeting called to order at 7:00 p.m. by Chairman Ray Lubus

2. Public Comment

Mr. Bird, Gillotti Road approached the Commission. He wanted to tell the Commission what a great job the marina staff was doing. He especially commended Jeff Lamanna for being friendly, courteous and very helpful at the marina.

Mr. Jim Mitchell, Sr. Gate Attendant approached the Commission. He wanted to let the Commission know they should plan for a new motor control for the security gate next year.

He also asked the Commission not consider raising the rates for the marina, he felt they were not getting the extras they were promised.

3. Remarks from Parks & Recreation Chairman

Mr. Lubus reported 3 of 4 sub-committee's had met since last meeting. He explained tonight was the election of officers and that the Commission had accomplished a lot last year and he looked forward to another great year.

4. Remarks from Parks & Recreation Director

Mr. Merullo thanked the Parks & Recreation Commission for all their help this year. He felt they had had a very successful summer.

5. Old Business

Review of summer movie program

Mr. Lubus felt there were several things that needed to be addressed.

Policy & Procedures guide. He felt it was time for the Commission to move forward on this and he volunteered to draft a proposal.

Mr. Merullo reported there were 2 solid nights, and 1 rain out. He felt the animated movies were better attended (400-450 at each movie). He also felt he needed a trained crew to help set up and break down. He felt 3 for the screen and 2 for sound would be sufficient. Mr. Merullo reported it cost \$830.0 for 4 movies in overtime for B&G staff. Mr. Lubus agreed we should hire a crew and train them.

Mr. Merullo reported Kim Hanson charged \$1,400 to do the sound for the movies.

Mr. Lubus asked Mr. Hodge if there were any costs to use Squantz. Mr. Hodge stated they are trying to charge us but he hoped he could work out a trade off.

Mr. Merullo reported the Squantz staff was very helpful. He suggested next year they go with the same number of movies with a trained staff. He also asked for more volunteers and felt there could be more advertising.

The Commission discussed the bouncy house and slide.

Mr. O'Keeffe asked if they could ban coolers, Mr. Hodge stated no because it is a state park. Mr. Hodge thought maybe some of the movies could be shown at Galanti Stadium.

Mr. Lubus asked what would be needed for a budget next year. The commission discussed and felt \$5,000 would cover it. Mr. Merullo will contact Pepsi and see if they would sponsor us again next year. Mr. Hodge felt we may be able to rent the crew and equipment for \$1,500-1,800.

Mr. Tripp will work with Mr. Lubus to write Policies and Procedures.

Review of Summer Camp / Beach.

CAMP

Mr. Merullo distributed a letter from camp director Brian Stroh. The Commission reviewed. Camp profits were approx. \$10,000 7th graders were a big percentage of enrollment.

Ms. Anderson felt they should make field trips mandatory.

Mr. O'Keeffe had heard every one was happy and felt it was run well.

BEACH

Mr. Merullo reported the beach did not make money. He reported it was very hard for him to be there to supervise and suggested they hire a director next year. He also stated he had been in contact with Bob Greer and he had shown some interest.

Mr. Merullo reported they had 2 septic failures. There were plans to do testing tomorrow to see of the planned area for new septic would work.

The commission discussed paying a portion of the fee for WSI's

Mr. Lamanna reported the Lions Club held a Senior Picnic at the beach and the Concession stand had been left very clean.

Mr. Merullo reported the swim docks were in rough shape and the hinges were sloppy. The Commission discussed the Blue Raiders. Mr. Lubus asked the Waterfront Sub-Committee to look into any problems.

October 28th is the deadline for boats to be removed from the Marina. The Commission requested a post card be sent out as a reminder.

6. Sub-committee reports

LONG RANGE PLANNING/CAPITAL IMPROVEMENT

Mr. Burfiend reported they had prioritized the '07-'08 list.

Dirt area behind Rebel Turf

Mr. Merullo reported there was \$32,878 in the new field facility fund. He stated he had volunteers that would like to rent 2 machines for 1 week at a cost of approx. \$7,000 to level the area and create an open drainage way. He explained they were trying to get it completed this fall.

Concession Stand / Bathrooms

Mr. Burfiend explained they were trying to move the project ahead this year. Mr. Merullo explained they had Score Fund donations and they were asking the Commission to approve the pre-drawings so the architect can go ahead with construction drawings to get some solid numbers. The Commission reviewed the drawings.

Mr. O'Keeffe requested they look at John McGirk's plans drawn 10 years ago. Mr. Merullo felt they did not fit what is there today. The Commission discussed.
