1. Call to Order: Chairman Sean Loughran called the meeting to order at 7:55 p.m.

3. Approval of Minutes from 6/14 & 7/12

4. Chairman Comments

Chairman Sean Loughran reported that the Dog Park is now open. Rules have been posted, the park has been busy and no issues have been reported.

He also reminded the Commission members that the next regular meeting is scheduled for Monday, September 13th.

- **5. Director Update** Recreation Director Linda Lull requested the Commission's feedback on the following:
 - a. Summer Movies There has been an increase of \$800 in setup costs for the movies compared to last year. The movie license fees have also increased by \$300 and there would also be a cost of \$145 for sandwich boards to advertise the movies if approved by the Commission. Fred Testor made a motion to approve these costs. Chris Van Steen seconded the motion.

b. - **a. Programming** Sean Loughran noted that an update should be provided in the fall from Brian Stroh and/or Linda Lull.
- **b.** Waterfront Linda Lull reported that during the week of 8/30 9/3 and Labor Day Weekend there is limited coverage at the town park due to lifeguards returning to school. First Selectman John Hodge suggested that only the south beach should be opened when coverage is limited. Ms. Lull asked the Commission members to consider volunteering to provide adult supervision during these times. Mr. Hodge reported that the swim docks are in very good shape.
