Zoning Commission meeting February 5, 2020 3. Site Plan-SI-20-006; Site Plan for 12 Renda Street under Section 8.1-Site Plan Standards. Rehabilitate a water treatment facility at our Renda Well Field for Aquarian Water. Applicant Snyder Civil Engineering.

Mark Fois from Aquarion Water and Zach Kuegler from Snyder Civil Engineering spoke of a project to rehabilitate a water treatment facility on Renda Street. This project would replace an underground storage single tank with twin tanks and upgrade to current regulations. This project would stay within the same footprint and will meet the ten foot property line regulation. There was a brief discussion of buffers and it was noted that vegetation will be planted. It was noted that Zoning Chairman John Moran would like to see if list of vegetation plantings ahead of time.
