- **1. Inspection-** 5 High Trail- Zoning Enforcement Officer Evan White noted that neighbors at 35 Ridge Road would like a follow up inspection of this property. It was decided to have a special meeting for this once Chairman John Moran is back from vacation in March or April.
- 2. Discussion- AirBnB Regulations and Short Term Vacation rentals- The Commission decided to table this item at this time.
- **3. Discussion** Regulation 7.1.1.2-Pre-Existing non-conforming lots with setbacks- Evan White noted that the town has approved putting money in the budget in the amount of \$30,000 per year for two years to hire consultants for a review of all regulations. It was noted that regulations should be consistent with surrounding towns. There was a discussion of regulations for setbacks and impervious coverage.
- **4. Discussion-** Updating Parking Regulations-Bank- It was decided to change the regulations just for banks at this time. The number of required parking spots for banks will be cut in half. There was a suggestion of possibly changing parking regulations everywhere in the future.
