Short Term Rentals - Amendment to Zoning Regulation under section 3.1.1(G)

Evan White ZEO advises Zoning decided to regulate and legalize short term rentals. A short term rental is defined by a one to six days rental term. People will have to register for a special permit without the public hearing and would have to abide by the conditions outlined. ZEO explained reasoning behind proposed changes that included owners on site, parking, fees for licensing, and insurance. Commissioners expressed concerns with enforcement and homeowners who are out of town.

Patrick Hearty motioned for positive referral with revisions to item two. Ernie Lehman seconded the motion. Vote 1-4-0 (Motion denied)

Regulation 7.1.1.2 - Improved Lots Not in Validated or Approved Subdivisions

Ernie Lehman motioned for a positive referral to regulation 7.1.1.2 with respect to the addition of the additional sentence: Only to the extent that such construction will not increase the nonconformity as it pertains to height, coverage, and setbacks. Gregg Williams seconded the motion. Vote 5-0-0 (Motion approved)
