#### <u>Discussion and vote to approve request from Company A and the Fire Department to access</u> funds in the Fire Department Reserve Fund for the purchase of Tanker 7

Fire Chief Bruce Taylor spoke of the purchase of Tanker 7 and noted that they plan to sell the old vehicle.

Pat Del Monaco made a motion to approve the request from the Fire Department to access funds in the Fire Department Reserve Fund for the purchase of Tanker 7 with \$353,600 from the reserve fund and the remaining 15% being paid for by Company A Fire Department. #### **Economic Development Commission Annual report**

Myke Furhman from the Economic Development Commission gave a brief overview of what the commission has accomplished since its inception in April of 2019. The main initiative of the commission has been a community survey which has yielded over 500 responses to date. They are

BOS- Minutes 11/14/2019 Page 2 of 3 continuing community outreach by attending realtor events and holding a Happy Hour at the 440 Line Restaurant on Thursday, November 21<sup>st</sup> to get area business owners together. Their goals for 2020 are to increase collaboration with area towns, increase marketing efforts and advertisements, and to streamline Town approvals and regulations. Selectman Kim Hanson asked the committee to consider how results from initiatives are tracked.

# FEMA update

Pat Del Monaco noted that \$1.9 million from FEMA was received today as reimbursement from the May 15, 2018 storm. The total received from FEMA to date is \$1,997,861.30. Administrative costs in the amount of \$133,190.75 are yet to be received. The total reimbursed is approximately \$2.1 million which amounts of 84% of the total expenses from the storm. Selectman Khris Hall noted that this money goes back into the general fund and will be available for any future emergencies that may arise.

**<u>Public Comment</u>**- Bob Jano reminded resident of a Town ordinance that requires homeowners to have their address visible on their house. He noted that this is very important in case the fire department or ambulance needs to find houses in an emergency.
