Pat Del Monaco responded to Ms. Thiel and noted that the 8-24 referral does not require a hearing and spoke of the role of the Planning Commission specifically regarding referrals.

Kim Hanson noted that the previous purchase that went before the Planning Commission took approximately three months and was rejected primarily because of the neighbors' input that were notified well in advance. He noted that the entire Planning Commission meeting on April 15<sup>th</sup> that gave the 8-24 referral was comprised of mostly plans regarding the project but didn't address how it fit into the Plan of Conservation and Development.

## **Coronavirus update**

Pat Del Monaco reminded everyone that there is an Executive Order that everyone is required to wear a mask in public. She spoke of how wearing a mask protects other people. There are 94 confirmed cases in New Fairfield and the numbers throughout the State are rising but the numbers of hospitalizations in Connecticut are decreasing. The State is increasing the testing that may make the numbers go up in the near future. The Governor has put together a reopening

advisory council and has worked with surrounding states for a regional plan. It is hopeful that there will be a plan in place by the end of May with reopening in June.

# **Budget Update**

Pat Del Monaco noted that the BOF will meet virtually every Wednesday throughout the month of May to discuss the budget. According to the Governor's order, there will be no budget referendum this year and the Mil Rate will be adopted by the BOF. As a result, the BOF is especially encouraging public comment regarding the budget.
