Discussion of Medical Plan for 2020-2021

Tom Kowalchick from USI spoke of premiums from Anthem for the medical plan. Currently, the town has an Individual Stop Loss of \$200,000 and an Aggregate Stop Loss of \$120%. There was a discussion of the best option for the town and specifically the cost of lasering for one member. The Board spoke of the risk of eliminating Aggregate Stop Loss and increasing the Individual Stop Loss. There was a discussion of how COVID 19 could affect medical claims in the future.

Vote on Medical Plan for 2020-2021

Wes Marsh to approve the Medical Plan for 2020-2021 with \$150,000 ISL including the lasering of one member for \$350,000 and 120% ASL with a prescription plan for an annual premium cost of \$433,729.32. Anthony Yorio seconded the motion. **Vote: 6-0-0 (Motion approved)**

New Fairfied Tax Collector Suspense List

Tax Collector Kerrie Greening explained that the suspense list is comprised of delinquent taxpayers that are sent to a collection agency. There is an 18% fee to the collection agency of which the taxpayer must pay 15% for any money collected. It was noted that fees are only paid on money collected.

Wes Marsh made a motion to approve the Suspense List for the Town of New Fairfield dated May 28, 2020. Cheryl Reedy seconded the motion. **Vote: 6-0-0 (Motion approved)**

Vote to adopt the BOS and BOE budgets for fiscal year 2020-2021

Wes Marsh made a motion to approve and adopt the town government expenditures totaling \$12,276,720 from the general fund and \$749,000 from the capital and nonreccurring fund and \$928,256 from other governmental funds for the fiscal year commencing July 1, 2020 and ending June 30, 2021 be approved. Cheryl Reedy seconded the motion. **Vote: 6-0-0 (Motion approved)**

Wes Marsh made a motion to approve and adopt the education expenditures totaling \$43,709,084 from the general fund for the fiscal year commencing July 1, 2020 and ending June 30, 2021 be approved. Jane Landers seconded the motion. **Vote: 6-0-0 (Motion approved)**

Vote to set the Mill Rate for the fiscal year 2020-2021

Wes Marsh made a motion to set the Mill rate for the fiscal year July 1, 2020 through June 30, 2021 at 30.58 mills. Cheryl Reedy seconded the motion. **Vote: 6-0-0 (Motion approved)**
