• Request for 10% maintenance bond for \$20,000 for Quail Ridge at Shortwoods Road. Cynthia advised she had not received a letter from the town engineer verifying that he has done an inspection and recommending a bond reduction. Commissioners agree to pend this item until the June meeting since no letter was received.

• Lighting Study – Patrick Hearty reviews the documents from Jane Didona with the commissioners. He noted the site analysis and lighting site plan cost was \$1,500. Patrick also advised that the commission still need to hire an electrical engineer. Cynthia notes that the commission now has a plan that outlines the best way to implement additional lighting, the equipment needed, and possibilities for expansion of the plan. Patrick will follow up on the following: Lighting across the street on a state road, check to see if fixtures can be placed on the building, making sure the lighting fixtures are not shining up, cost of the footings for the fixtures.
