Michael Del Monaco noted that Suzanne Kloos is filling in as Recording Secretary for this meeting. It is hopeful this position will be filled by the next regular PBC meeting.

High School and Consolidated Early Learning Academy/MHHS Building projects Information Items

• Architect update

Christine O'Hare from JCJ Architecture spoke of the CELA project and noted that they have received preliminary draft estimates and have been working with O&G to reconcile the estimates. The draft estimates for the high school should be ready soon as a first preliminary

estimate. Scott Pellman from Colliers noted that the CELA estimates could possibly be ready next week or by the next PBC meeting of June 23. The reconciliation for the high school is expected to be ready by June 30. Michael Del Monaco asked to have the estimates given to the PBC members a few days in advance to allow for review.

Christine O'Hare noted that they have been meeting with the School Safety and Security Committee and the Fire Department and discussed site specific items. JCJ has also met with the administrators for both the CELA and high school projects and reviewed plans. These plans will be presented to the PBC along with the cost estimates.

•Consulting Engineering Services

Mike Bouchard from CES gave an overview of two options for HVAC. He compared the traditional VAV and VRF (Variable Refrigerant) and spoke of the pros and cons of both options. There was a brief discussion of the mixing of air and technology to mitigate virus transmissions. Mr. Bouchard noted that a major benefit of VRF is that fresh air is circulated at all times and is much more energy efficient. It was noted that the life expectancy for both options is approximately 20 years.

OPM update

Scott Pellman from Colliers noted that a lot of time has been spent reviewing the estimates on the schematic level for CELA. It is hopeful that a reconciled estimate will be available by next week. They have been working on the high school design and comments and will get the comments to JCJ by the end of the week. They will set up a reconciliation meeting with O&G to discuss the comments. A State meeting is set up for June 24. They expect to have the budget for the CELA project to the PBC by June 23.

Lorel Purcell from O&G noted that they are finishing the cost estimates for CELA and the high school.
